DANCER AND PARENT

NUTCRACKER CONTRACT

This document signifies an agreement between Red River Dance Theatre Company, hereinafter referred to as **THE COMPANY**, and _____ and his/her parents, hereinafter referred to as **DANCER and PARENTS**. It is understood that all matters related to training and performing will be under the direction of the Artistic Director; all matters related to operating the organization will be under the direction of **THE COMPANY**.

THE COMPANY agrees to provide the following:

1. Formal instruction according to a schedule recommended by the Artistic Director and approved by **THE COMPANY** including classes, choreographic sessions, and rehearsals, all under the supervision of the Artistic Director.
2. Costuming for productions, with the exception of shoes, tights, make-up, and personal garments.
3. Production aspects of the performance.
4. Accident and liability insurance for activities associated with training, rehearsing, and performing.
5. Administrative support for students in their school environment (obtaining excused absences, verifying participation for club service requirements, etc.)

THE DANCER and PARENT(S) agree to provide the following:

1. **Non-refundable performance fee of \$155.00 for the first child and \$130.00 for each subsequent child. This fee includes one t-shirt. Fee may be split into two (2) payments: \$80.00 due by September 13, 2014, and \$75.00 due by October 18, 2014. NON-PAYMENT OF THE PERFORMANCE FEE RENDERS A DANCER INELIGIBLE FOR PARTICIPATION IN THE NUTCRACKER.** Limited financial aid is available.
2. Recognition of the Artistic Director as the responsible party for disciplinary policy and enforcement.
3. Compliance with Company Rules.
4. Appropriate dance attire, shoes, hair.
5. A current medical information and release form.
6. Advance written notice of absence to the Artistic Director (excuse form enclosed). If dancer is ill, please notify Artistic Director as soon as possible.
7. Cooperation with **THE COMPANY** in planning for volunteer involvement.
8. I hereby authorize **THE COMPANY** to use any appropriate pictures of my child taken by an authorized member of the staff for use in RRDC publications and publicity material. Any pictures of the rehearsals taken by authorized members will not identify the dancers by name; pictures will be available for sale to parents and participants through <http://www.redriverdance.smugmug.com>.

This contract is in effect for Red River Dance Theatre Company's production of The Nutcracker, beginning September 1, 2014, and ending on December 1, 2014.
